The NDNRT and PF are offering a Continuous Conservation Reserve Program (CRP) sign-up incentive payment to qualified landowners. The CRP Partner Incentive (CPI) will be a one-time incentive payment, issued after a landowner enrolls into the Continuous CRP practices CP23A, CP37 and/or CP38 SAFE. The CPI payment only applies to new grass seedings and associated CRP wetland acres. Payment will be issued directly to landowners by the Trust based on CRP-1 acreage total. Public access is not required to be eligible for CPI. The CPI will be offered for CRP enrollment in Adams, Barnes, Grand Forks, Nelson and Sargent counties:



\$30/acre one-time, up front for 10 year contracts

\$50/acre one-time, up front for 15 year contracts

WETLAND RESTORATION INCENTIVE

DU is offering an incentive payment to landowners who enroll in Continuous Conservation Reserve Program (CRP) practices CP23A, CP27, CP37 and/or CP38 SAFE Coteau Drift Prairie Waterbank, and install new ditch plug(s) on Prior Converted wetland(s). A one time incentive payment will be issued directly to landowners by DU for completed wetland restorations (installed ditch plugs) identified on an approved NRCS conservation plan and maps. Public access is not required to be eligible for DU wetland restoration incentives and will be offered for CRP enrollment in Barnes, Sargent and Nelson counties:



\$30/restored wetland acre up to \$150/basin one-time, up front for 10 year contracts

\$40/restored wetland acre up to \$200/basin one-time, up front for 15 year contracts

NDGF is offering a one time, upfront Habitat Incentive Payment (HIP) on new grass planting acres enrolled in Continuous CRP practices CP23, CP23A, CP28, CP37, CP41 and/or CP38 SAFE. Eligibility for HIP requires new CRP grass planting acres and enrollment in the NDGF PLOTS program within two years of CRP-1 start date. Additional CRP access and HIP payments are available to landowners who open their land to walk in hunting access through PLOTS. PLOTS rental and HIP payments are paid in addition to USDA CRP payments by the NDGF. PLOTS and HIP's will be offered for CRP enrollment in Adams, Barnes, Grand Forks, Nelson and Sargent counties:



\$10/CRP acre/year access payment (this is in addition to USDA CRP rental payment)

\$30/acre one time, upfront Habitat Incentive Payment
